I. Situation Overview

On 24 November 2024 at around 12:30 PM, a fire incident occurred in Brgy. Cabiawan, San Remigio, Antique.

A total of **two (2) families** or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were totally damaged in Brgy. Cabiawan, San Remigio, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,350.88** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
