I. Situation Overview

On 24 November 2024 at around 8:30 AM, a fire incident occurred at Purok Tinago, Brgy. Daga, Cadiz City, Negros Occidental.

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Daga, Cadiz City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,571.28** worth of assistance was provided to the affected family composed of **₱5,871.28** from **DSWD** and **₱11,700.00** from the **Local Government Unit (LGU)** (see Annex D).
