I. Situation Overview

On 16 October 2024 at around 1:00 AM, a fire incident occurred in Brgy. Polo, City of Alaminos, Pangasinan.

One (1) family or eight (8) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Polo, City of Alaminos, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱26,335.11** worth of assistance was provided to the affected family; of which, **₱21,335.11** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
