I. Situation Overview

On 23 September 2024 at around 7:08 AM, a fire incident occurred in Brgy. Tabuc Suba, Jaro, Iloilo City. The fire was declared out at around 8:54 AM.

A total of **six (6) families** or **30 persons** were affected in **Brgy. Tabuc Suba, Jaro, Iloilo City** (see Annex A).

A total of **six (6) families** or **30 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were totally damaged in **Brgy. Tabuc Suba, Jaro, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱93,941.44** worth of assistance was provided to the affected families; of which, **₱48,788.64** from **DSWD** and **₱45,152.80** from the **Local Government Unit (LGU)** (see Annex D).
