

DSWD DROMIC Report on the Fire Incident in Brgy. Tabuc Suba, Jaro, Iloilo City

27 December 2024, 6AM

I. Situation Overview

On 23 September 2024 at around 7:08 AM, a fire incident occurred in Brgy. Tabuc Suba, Jaro, Iloilo City. The fire was declared out at around 8:54 AM.

II. Status of Affected Areas and Population

A total of six (6) families or 30 persons were affected in Brgy. Tabuc Suba, Jaro, Iloilo City (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **30 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were totally damaged in **Brgy. Tabuc Suba, Jaro, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱93,941.44 worth of assistance was provided to the affected families; of which, ₱48,788.64 from DSWD and ₱45,152.80 from the Local Government Unit (LGU) (see Annex D).
