

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Cansojong, City of Talisay, Cebu

22 June 2025, 6PM

## I. Situation Overview

On 29 November 2024, a fire incident occurred in Brgy. Cansojong, City of Talisay, Cebu. The fire was declared out at around 11:29 AM.

## II. Status of Affected Areas and Population

A total of **44 families** or **168 persons** were affected in **Brgy. Cansojong, City of Talisay, Cebu** (see Annex A).

## **III.** Status of Displaced Population

#### **Inside Evacuation Center**

A total of **44 families** or **168 persons** sought temporary shelter at the **Brgy. Cansojong Gymnasium, City of Talisay, Cebu** (see Annex B).

## IV. Damaged Houses

A total of **28 houses** were damaged; of which, **26** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Cansojong, City of Talisay, Cebu** (see Annex D).

## V. Cost of Humanitarian Assistance Provided

A total of ₱638,000.00 worth of assistance was provided to the affected families; of which, ₱488,000.00 from DSWD and ₱150,000.00 from the Local Government Unit (LGU) (see Annex E).
