I. Situation Overview

On 12 November 2024 at around 5:30 PM, a fire incident occurred in Brgy. San Joaquin, Macrohon, Southern Leyte.

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. San Joaquin, Macrohon, Southern Leyte** (see Annex A).

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. San Joaquin, Macrohon, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱46,043.00** worth of assistance was provided to the affected families composed of **₱16,043.00** from **DSWD** and **₱30,000.00** from the **Local Government Unit (LGU)** (see Annex D).
