

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Sangali, Zamboanga City

08 December 2024, 6AM

I. Situation Overview

On 22 January 2024 at around 11:45 AM, a fire incident occurred in Brgy. Sangali, Zamboanga City. The fire was declared out at around 1:42 PM.

A total of **41 families** or **187 persons** were affected in **Brgy. Sangali, Zamboanga City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **41 families** or **187 persons** sought temporary shelter at the **Brgy. Sangali Covered Court** in **Zamboanga City** (see Annex B).

IV. Damaged Houses

A total of **41 houses** were damaged; of which, **36** are **totally damaged** and **five (5)** are **partially damaged** in **Brgy. Sangali, Zamboanga City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱152,930.00 worth of assistance was provided by **DSWD** to the affected families (see Annex D).
