I. Situation Overview

On 13 January 2025 at around 2:00 PM, a fire incident occurred in Brgy. 1, Salcedo, Eastern Samar. The fire was declared out at around 2:35 PM.

One (1) family or four (4) persons are affected in Brgy. 1, Salcedo, Eastern Samar (see Annex A).

Outside Evacuation Center

One (1) family or four (4) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. 1, Salcedo, Eastern Samar (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,702.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).

- ₱111.09 million worth of other FNIs at NROC, VDRC, and DSWD FO VIII warehouses.

b. Food and Non-food Items (FNIs)

14 January 2025	 DSWD FO VIII, in coordination with the Municipal Action Team and the Municipal Social Welfare and Development Office (MSWDO) of Salcedo, distributed FNIs to the family affected by the fire incident.

c. Internally Displaced Person (IDP) Protection

14 January 2025	 DSWD FO VIII provided guidance to the LGU of Salcedo to conduct a psychosocial intervention to the family affected by the fire incident.

d. Other Activities

DATE	ACTIVITIES
14 January 2025	 DSWD FO VIII referred the affected family to the Crisis Intervention Section (CIS) for possible provision of financial assistance through the Assistance to Individuals in Crisis Situation (AICS). DSWD FO VIII closely coordinated with the LGU of Salcedo and other concerned offices for significant updates and any requests for augmentation.
