I. Situation Overview

On 23 January 2025 at around 7:39 AM, a fire incident occurred in Brgy. Biasong, Libagon, Southern Leyte.

DSWD FO VII referred the affected family to the Crisis Intervention Section for further provision of financial assistance through the Assistance to Individuals in Crisis Situation (AICS).
