I. Situation Overview

On 08 December 2024 at around 8:45 PM, a fire incident occurred at Sitio Lubi, Brgy. 3 (Pob.), Bacolod City, Negros Occidental.

A total of **₱10,695.76** worth of assistance was provided to the affected person; of which, **₱6,405.76** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
