

DSWD DROMIC Report on the Fire Incident in Brgy. 98, Tacloban City

05 January 2025, 6PM

I. Situation Overview

On 12 November 2024 at around 11:52 PM, a fire incident occurred in Brgy. 98 (Camansinay), Tacloban City. The fire was declared out at around 12:30 AM.

One (1) family or **four (4) persons** were affected in **Brgy. 98, Tacloban City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 98, Tacloban City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱25,000.00** worth of assistance was provided to the affected family; of which, **₱10,000.00** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
