

DSWD DROMIC Report on the Fire Incident in Brgy. Alaoa, Tineg, Abra 09 January 2025, 6PM

I. Situation Overview

On 20 November 2024 at around 12:30 PM, a fire incident occurred at Sitio Sabangan, Brgy. Alaoa, Tineg, Abra. The fire was declared out at around 2:30 PM.

A total of **three (3) families** or **19 persons** were affected in **Brgy. Alaoa, Tineg, Abra** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **19 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

Three (3) houses were **totally** damaged in **Brgy. Alaoa, Tineg, Abra** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱58,200.00** worth of assistance was provided to the affected families; of which, **₱28,200.00** from **DSWD** and **₱30,000.00** from the **Local Government Unit (LGU)** (see Annex D).
