I. Situation Overview

On 12 December 2024 at around 10:45 AM, a fire incident occurred at Brgy. Bagacayan, Igbaras, Iloilo. The fire was declared out at around 11:50 AM.

One (1) house was totally damaged in Brgy. Bagacayan, Igbaras, Iloilo (see Annex C).

v. Cost of Humanitarian Assistance Provided

A total of **P7,628.00** worth of assistance was provided to the affected families; of which, **P6,298.00** from **DSWD** and **P1,330.00** from the **Local Government Unit (LGU)** (see Annex D).
