

DSWD DROMIC Report on the Fire Incident in Brgy. Bagacayan, Igbaras, Iloilo

03 January 2025, 6PM

I. Situation Overview

On 12 December 2024 at around 10:45 AM, a fire incident occurred at Brgy. Bagacayan, Igbaras, Iloilo. The fire was declared out at around 11:50 AM.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Bagacayan, Igbaras, Iloilo** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

One (1) family or three (3) persons sought temporary shelter in **Day Care Center** in **Brgy. Bagacayan, Igbaras, Iloilo** (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bagacayan, Igbaras, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,628.00** worth of assistance was provided to the affected families; of which, **₱6,298.00** from **DSWD** and **₱1,330.00** from the **Local Government Unit (LGU)** (see Annex D).
