I. Situation Overview

On 28 November 2024 at around 11:21 AM, a fire incident occurred in Brgy. Burirao, Lambunao, Iloilo. The fire was declared out at around 12:00 PM.

V. Cost of Humanitarian Assistance Provided

A total of **₱6,361.00** worth of assistance was provided to the affected family; of which, **₱5,588.00** from **DSWD** and **₱773.00** from the **Local Government Unit (LGU)** (see Annex D).
