

## **DSWD DROMIC Report on the Fire Incident in Brgy. Dado, Alamada, North Cotabato**

15 January 2025, 6AM

### **I. Situation Overview**

On 18 December 2024 at around 4:52 PM, a fire incident occurred at Brgy. Dado, Alamada, North Cotabato. The fire was declared out at around 8:00 PM.
