

## DSWD DROMIC Report on the Fire Incident in Brgy. Danglas, Danglas, Abra

09 January 2025, 6PM

### I. Situation Overview

On 10 December 2024 at around 1:06 PM, a fire incident occurred at Brgy. Danglas, Danglas, Abra. The fire was declared out at around 3:30 PM.

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or three (3) persons** were temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was totally damaged in **Brgy. Danglas, Danglas, Abra** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱34,561.00** worth of assistance was provided to the affected families; of which, **₱29,561.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
