

DSWD DROMIC Report on the Fire Incident in Brgy. Handumanan, Bacolod City, Negros Occidental

09 January 2025, 6AM

I. Situation Overview

On 31 December 2024 at around 11 PM, a fire incident occurred in Brgy. Handumanan, Bacolod City, Negros Occidental. This resulted in the displacement of a family, who then sought temporary refuge with the relatives.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in **Brgy. Handumanan, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Handumanan, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,695.76** worth of assistance was provided to the affected family; of which, **₱6,405.76** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
