I. Situation Overview

On 12 December 2024 at around 6:45 AM, a fire incident occurred at #03 Benitez Compound, Brgy. Lower Magsaysay, Baguio City. The fire was declared out at around 7:32 AM.

A total of **₱49,106.92** worth of assistance was provided by the **DSWD** to the affected families (see Annex D).
