





DSWD DROMIC Report on the Fire Incident in Brgy. Nagsupotan, San Juan, Ilocos Sur

20 January 2025, 6PM

I. Situation Overview

On 14 January 2025 at around 11:27 AM, a fire incident occurred in Brgy. Nagsupotan, San Juan, Ilocos Sur. According to Bureau of Fire Protection (BFP) San Juan, the fire caused was due to faulty electrical wiring and it was declared out at around 11:42 AM.

One (1) family or five (5) persons were affected in Brgy. Nagsupotan, San Juan, Ilocos Sur (see Annex A).

Outside Evacuation Center

One (1) family or five (5) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Nagsupotan, San Juan, Ilocos Sur (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}27,840.26\$ worth of assistance was provided to the affected family; of which, \$\mathbb{P}17,840.26\$ from \$DSWD\$ and \$\mathbb{P}10,000.00\$ from the Local Government Unit (LGU) (see Annex D).
