

## DSWD DROMIC Report on the Fire Incident in Brgy. Polangi, Taft, Eastern Samar 12 March 2025, 6AM

### I. Situation Overview

On 25 February 2025 at around 6:40 PM, a fire incident occurred in Brgy. Polangi, Taft, Eastern Samar. The fire was declared out at around 7:10 PM.

A total of **four (4) families** or **16 persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. Polangi, Taft, Eastern Samar** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱62,320.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
