18 January 2025, 6AM

I. Situation Overview

On 14 January 2025 at around 2:00 PM, a fire incident occurred in Brgy. Rosal, Libacao, Aklan. The fire was declared out at around 5:00 PM.

One (1) person temporarily stayed with their relatives and friends (see Annex B).

One (1) house was **totally damaged** in **Brgy. Rosal, Libacao, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,235.44** worth of assistance was provided to the affected individual; of which, **₱6,735.44** from **DSWD** and **₱3,500.00** from the **Local Government Unit (LGU)** (see Annex D).
