I. Situation Overview

On 07 January 2025 at around 8:00 PM, a fire incident occurred in Brgy. Singcang-Airport, Bacolod City.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Singcang-Airport, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,000.00** worth of assistance was provided to the affected family composed of **₱4,710.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).

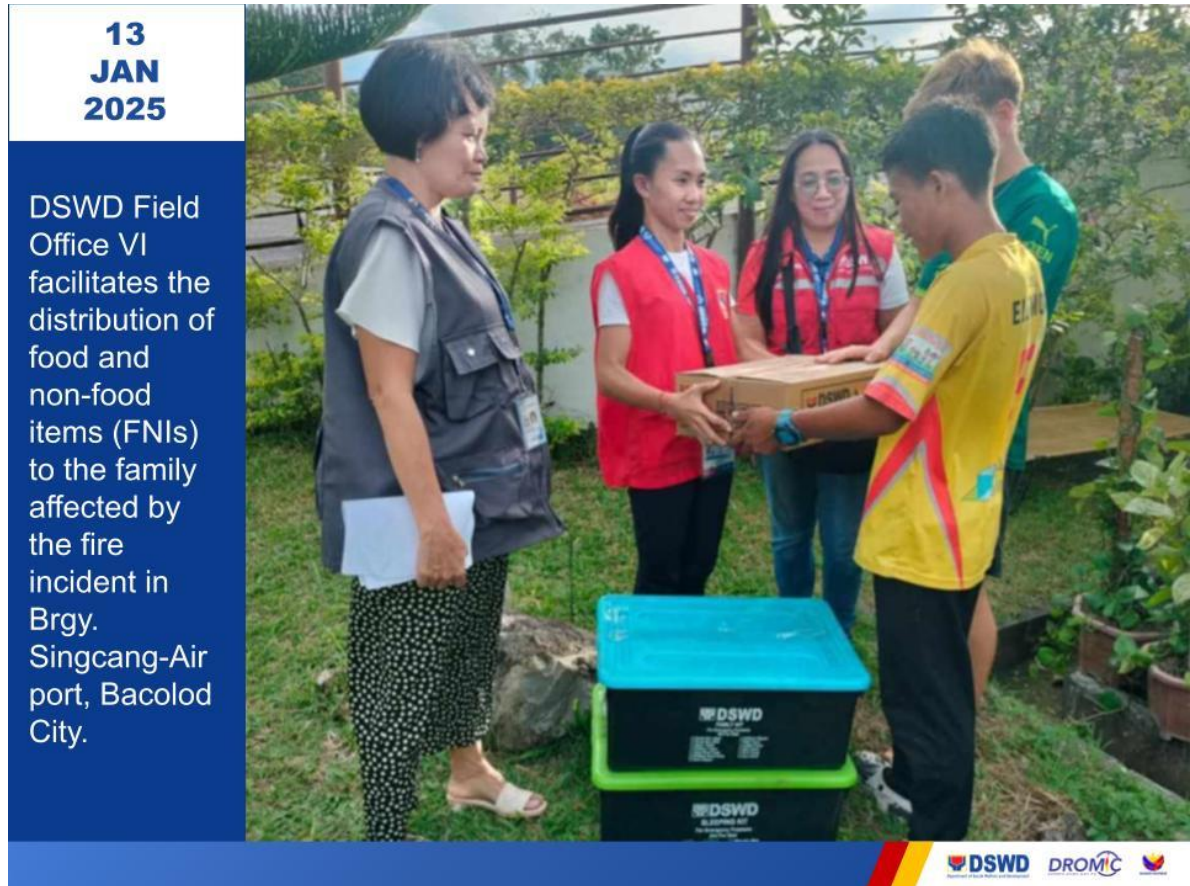
