

DSWD DROMIC Report on the Fire Incident in Brgy. Toboy, Asingan, Pangasinan

12 January 2025, 6PM

I. Situation Overview

On 28 November 2024 at around 12:35 PM, a fire incident occurred in Brgy. Toboy, Asingan, Pangasinan.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, in coordination with the Local Government Unit (LGU) of Asingan, Pangasinan, provided relief assistance in the form of food and non-food items to support the immediate needs of the affected family.

One (1) family or two (2) persons were affected in Brgy. Toboy, Asingan, Pangasinan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or two (2) persons are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Toboy, Asingan, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱18,132.10 worth of assistance was provided to the affected family composed of ₱7,532.10 from DSWD and ₱10,600.00 from the Local Government Unit (LGU) (see Annex D).
