

DSWD DROMIC Report on the Fire Incident in Brgy. Vista Alegre, Ilog, Negros Occidental 09 January 2025, 6AM

I. Situation Overview

On 02 October 2024 at around 9:20 PM, a fire incident occurred at Purok Santan, Brgy. Vista Alegre, Ilog, Negros Occidental. This resulted in the displacement of several families, who chose to stay with their respective relatives.

A total of **two (2) families** or **seven (7) persons** were affected in **Brgy. Vista Alegre, Ilog, Negros Occidental** (see Annex A).

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Vista Alegre, Ilog, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,956.00** worth of assistance was provided to the affected families by **DSWD** (see Annex D).
