I. Situation Overview

On 24 January 2025 at around 6:00 PM, a fire incident occurred in Brgy. Vizcaya, President Roxas, Capiz. The fire was declared out at around 7:00 PM.

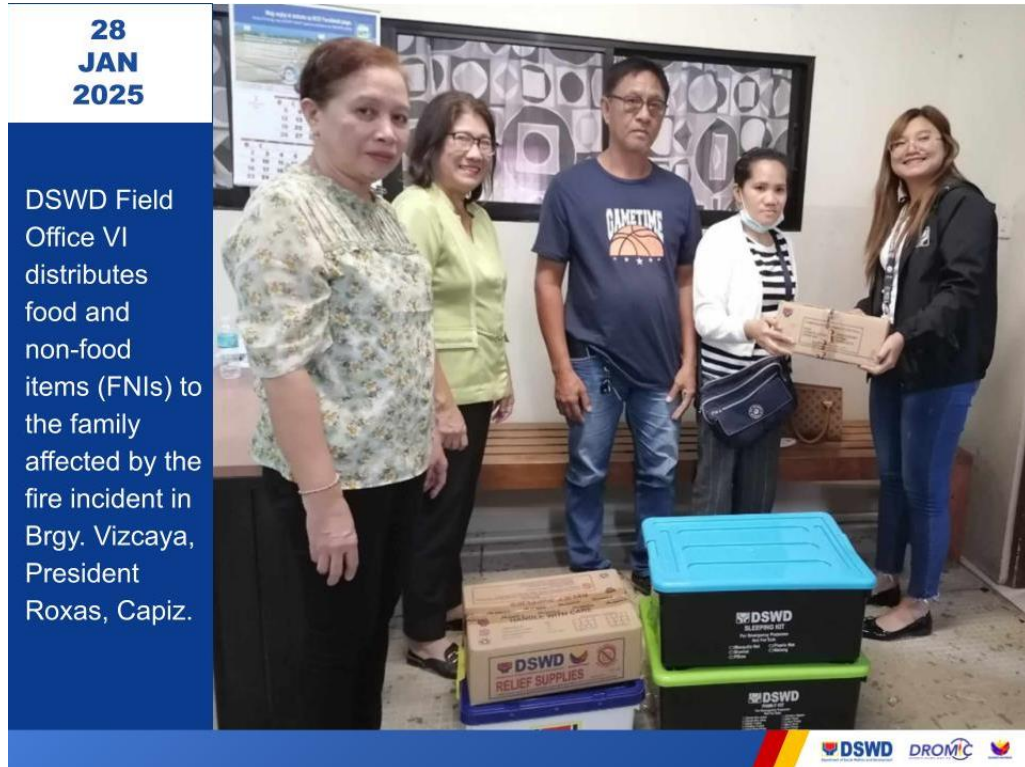
