

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 1, Salcedo, Eastern Samar

02 February 2025, 6PM

## I. Situation Overview

On 13 January 2025 at around 2:00 PM, a fire incident occurred in Brgy. 1, Salcedo, Eastern Samar. The fire was declared out at around 2:35 PM.

In response, the DSWD, through its Field Office in the Region VIII, provided relief assistance to support the immediate needs of the affected family.
