

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Duljo-Fatima, Cebu City, Cebu

01 February 2025, 6AM

I. Situation Overview

On 05 January 2025, a fire incident occurred in Brgy. Duljo-Fatima, Cebu City. The fire was declared out at around 4:31 AM.

II. Status of Affected Areas and Population

A total of **73 families** or **283 persons** were affected in **Brgy. Duljo-Fatima, Cebu City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **20 families** or **72 persons** sought temporary shelter at the **Brgy. Hall** in **Brgy. Duljo-Fatima, Cebu City** (see Annex B).

b. Outside Evacuation Center

A total of **53 families** or **211 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of **73 families** or **283 persons** were displaced in **Brgy. Duljo-Fatima, Cebu City** (see Annex D).

IV. Damaged Houses

A total of **32 houses** were damaged; of which, **28** are **totally damaged** and **four (4)** are **partially damaged** in **Brgy. Duljo-Fatima, Cebu City** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,709,409.00** worth of assistance was provided to the affected families; of which, **₱535,000.00** from **DSWD** and **₱2,174,409.00** from the **Local Government Unit (LGU)** (see Annex F).
