

DSWD DROMIC Report #1 on the Fire Incident in Brgy. 05, San Policarpo, Eastern Samar

as of 12 February 2025, 6PM

I. Situation Overview

On 05 February 2025 at around 8:45 AM, a fire incident occurred at Brgy. 05, San Policarpo, Eastern Samar. The fire was declared out at around 9:45 AM.

Relative to the incident, the DSWD through its Field Office in Region VIII, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or five (5) persons are affected in Brgy. 05, San Policarpo, Eastern Samar (see Annex A).

III. Damaged Houses

One (1) house was totally damaged in Brgy. 05, San Policarpo, Eastern Samar (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱28,677.50 worth of assistance was provided to the affected family composed of ₱8,677.50 from DSWD and ₱20,000.00 from the Local Government Unit (LGU) (see Annex C).
