

DSWD DROMIC Report #1 on the Fire Incident in Brgy. 63, Caloocan City as of 18 February 2025, 6AM

I. Situation Overview

On 14 February 2025 at around 5:00 PM, a fire incident occurred at M. Hizon St., 10th Avenue, Grace Park, Brgy. 63, Caloocan City. The fire was declared out at around 6:08 PM.

A total of **54 families** or **193 persons** are affected in **Brgy. 63, Caloocan City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **54 families** or **193 persons** currently taking temporary shelter at the **Brgy. Hall** in **Brgy. 63, Caloocan City** (see Annex B).

IV. Damaged Houses

A total of **14 houses** were damaged; of which, **13** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. 63, Caloocan City** (see Annex C).
