

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Pangasugan, City of Baybay, Leyte

as of 28 February 2025, 6PM

I. Situation Overview

On 11 February 2025 at around 5:30 AM, a fire incident occurred at Purok 4, Brgy. Pangasugan, City of Baybay, Leyte and it was declared out at around 07:05 AM.

The incident has led to displacement of a family with a corresponding number of 11 individuals. Among them, five (5) were identified as solo renters.

In response, the DSWD Field Office VIII provided financial assistance through Assistance to Individuals In Crisis Situations (AICS) to support the immediate needs of the affected family and individuals.

A total of six (6) families or 11 persons are affected in Brgy. Pangasugan, City of Baybay, Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **11 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Pangasugan, City of Baybay, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P35,000.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
