

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Buntatala, Jaro, Iloilo City as of 19 February 2025, 6AM

I. Situation Overview

On 16 February 2025 at around 2:00 PM, a fire incident occurred at Zone 7 Relocation Site, Brgy. Buntatala, Jaro, Iloilo City. The fire was declared out at around 2:58 PM.

II. Status of Affected Areas and Population

A total of **29 families** or **95 persons** are affected in **Brgy. Buntatala, Jaro, Iloilo City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **29 families** or **95 persons** currently taking temporary shelter at the **Brgy. Buntatala Covered Court** in **Jaro, Iloilo City** (see Annex B).

IV. Damaged Houses

A total of **12 houses** were damaged; of which, **nine (9)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Buntatala, Jaro, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱299,280.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
