

DSWD DROMIC Report #3 on the Fire Incident in Brgy. 28, Caloocan City as of 22 February 2025, 6AM

I. Situation Overview

On 12 February 2025 at around 2:15 AM, a fire incident occurred at Dagat-Dagatan Avenue, Brgy. 28, Caloocan City. The fire was declared out at around 5:40 AM.

The Department of Social Welfare and Development (DSWD), through its Field Office in the National Capital Region (NCR), provided relief augmentation to support the immediate needs of the affected families and individuals.

I. Status of Affected Areas and Population

A total of **170 families** or **680 persons** are affected in **Brgy. 28, Caloocan City** (see Annex A).

II. Status of Displaced Population

Inside Evacuation Center

There are **170 families** or **680 persons** currently taking temporary shelter at **Garlic Court Evacuation Center** in **Brgy. 28, Caloocan City** (see Annex B).

III. Damaged Houses

A total of **20 houses** were **totally damaged** in **Brgy. 28, Caloocan City** (see Annex C).

IV. Cost of Humanitarian Assistance Provided

A total of **₱838,769.80** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
