

# DSWD DROMIC Report #6 on the Effects of Shear Line

as of 28 February 2025, 6PM

## I. Situation Overview

On 20 February 2025, at approximately 4:00 AM, cloudy skies with scattered rains and isolated thunderstorms, attributed to the Shear Line, brought potential flash floods or landslides to the Visayas, MIMAROPA, Bicol Region, Caraga, Laguna, Rizal, and Quezon.

On the same day, continuous heavy rainfall in Camarines Norte, Camarines Sur, Catanduanes, Albay, and Masbate resulted in localized flooding near river channels and low-lying areas. Additionally, sustained rainfall in several municipalities of Agusan del Sur led to flooding, displacing families and individuals in the affected areas.


On 21 February 2025, flooding incidents were reported in Brooke's Point, Palawan, due to the continued heavy rainfall from the Shear Line.

On 22 February 2025, further continuous rainfall from the Shear Line caused flooding in certain parts of Eastern Visayas.

## II. Status of Affected Areas and Population

A total of **31,746 families** or **109,448 persons** are affected in **141 barangays** in **Regions MIMAROPA, V, VIII, and Caraga** (see Annex A).



### III. Status of Displaced Population

#### a. Inside Evacuation Center

A total of **892 families** or **3,021 persons** sought temporary shelter in **29 evacuation centers** in **Regions MIMAROPA, V, and Caraga** (see Annex B).

#### b. Outside Evacuation Center

A total of **3,000 families** or **11,461 persons** temporarily stayed with their relatives or friends (see Annex C).

#### c. Total Displaced Population

A total of **3,892 families** or **14,482 persons** were displaced in **Regions MIMAROPA, V, and Caraga** (see Annex D).

### IV. Cost of Humanitarian Assistance Provided

A total of **₱2,643,590.23** worth of assistance was provided to the affected families composed of **₱2,572,900.23** from **DSWD** and **₱70,690.00** from the **Local Government Units (LGUs)** (see Annex E).
