

DSWD DROMIC Report on the Drowning Incident in Brgy. Annafunan, Tumauini, Isabela

02 February 2025, 6PM

I. Situation Overview

On 3 December 2024, at around 5:00 PM, a drowning incident was reported in Brgy. Annafunan, Tumauini, Isabela, along the Cagayan River. The incident led to the loss of three young lives. The victims, aged eight (8), nine (9), and ten (10), were found lifeless after having succumbed to the drowning. Their bodies were subsequently retrieved from the river by local authorities.

In response to this devastating tragedy, the Department of Social Welfare and Development (DSWD), through its Field Office in Region II, swiftly mobilized to provide assistance to the affected families. The agency extended both immediate relief and financial support to help alleviate the burdens faced by the bereaved families, ensuring they received the necessary resources to cope with their loss during this difficult time.

II. Status of Affected Areas and Population

Three (3) families or three (3) persons were affected in Brgy. Annafunan, Tumauini, Isabela (see Annex A).

III. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}61,254.56\$ worth of assistance was provided to the affected families composed of \$\mathbb{P}46,254.56\$ from DSWD and \$\mathbb{P}15,000.00\$ from the Local Government Unit (LGU) (see Annex B).
