I. Situation Overview

On 28 January 2025 at around 1:30 PM, a fire incident occurred in Brgy. 19, City of Victorias, Negros Occidental.

One (1) house was **totally damaged** in **Brgy. 19, City of Victorias, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,499.28** worth of assistance was provided to the affected family; of which, **₱7,399.28** from **DSWD** and **₱2,100.00** from the **Local Government Unit (LGU)** (see Annex D).
