

DSWD DROMIC Report on the Fire Incident in Brgy. 35, Bacolod City, Negros Occidental

18 February 2025, 6AM

I. Situation Overview

On 13 February 2025 at around 5:00 PM, a fire incident occurred in Brgy. 35, Bacolod City, Negros Occidental.

II. Status of Affected Areas and Population

One (1) family or eight (8) persons were affected in Brgy. 35, Bacolod City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 35, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱10,790.00 worth of assistance was provided to the affected family; of which, ₱6,500.00 from DSWD and ₱4,290.00 from the Local Government Unit (LGU) (see Annex D).
