

DSWD DROMIC Report on the Fire Incident in Brgy. 6, Tacloban City, Leyte

02 February 2025, 6AM

I. Situation Overview

On 24 February 2023 at around 1:57 PM, a fire incident occurred in Brgy. 6, Tacloban City, Leyte. The fire was declared out at around 3:00 PM.

II. Status of Affected Areas and Population

A total of **six (6) families** or **27 persons** were affected in **Brgy. 6, Tacloban City, Leyte** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **two (2) families** or **11 persons** currently taking temporary shelter at the **Brgy. Hall** in **Brgy. 6, Tacloban City, Leyte** (see Annex B).

b. Outside Evacuation Center

There are **two (2) families** or **eight (8) persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

A total of **four (4) families** or **19 persons** are still displaced in **Brgy. 6, Tacloban City, Leyte** (see Annex E).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. 6, Tacloban City, Leyte** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱59,833.56** worth of assistance was provided by **DSWD** to the affected families (see Annex G).
