I. Situation Overview

On 22 December 2024 at around 7:58 PM, a fire incident occurred at Purok 4, Brgy. Abbag, Maddela, Quirino. The fire was declared out at around 9:00 PM.

One (1) house was **totally damaged** in **Brgy. Abbag, Maddela, Quirino** (see Annex C).

A total of **₱6,399.75** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
