

DSWD DROMIC Report on the Fire Incident in Brgy. Alos, City of Alaminos, Pangasinan

28 June 2023, 6PM

I. Situation Overview

On 18 January 2025 at around 3:34 AM, a fire incident occurred at Purok San Pablo, Brgy. Alos, City of Alaminos, Pangasinan.

In response, the DSWD, through its Field Office in Region I, together with the Local Government Unit (LGU) of the City of Alaminos, Pangasinan, provided relief and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **two (2) families** or **two (2) persons** were affected in **Brgy. Alos, City of Alaminos, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **two (2) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1) is totally damaged** and **one (1) is partially damaged** in **Brgy. Alos, City of Alaminos, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱59,240.10** worth of assistance was provided to the affected families composed of **₱41,918.70** from **DSWD** and **₱17,321.40** from the **Local Government Unit (LGU)** (see Annex D).
