I. Situation Overview

On 06 January 2025 at around 5:30 AM, a fire incident occurred in Brgy. Bitaogan, City of Passi, Iloilo. The fire was declared out at around 6:00 AM.

One (1) family or **two (2) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bitaogan, City of Passi, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱16,648.00 worth of assistance was provided to the affected family; of which, ₱6,648.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
