

DSWD DROMIC Report on the Fire Incident in Brgy. Bitoon, San Ricardo, Southern Leyte

02 February 2025, 6AM

I. Situation Overview

On 24 December 2024 at around 7:00 AM, a fire incident occurred in Brgy. Bitoon, San Ricardo, Southern Leyte. The fire was declared out on the same day.

One (1) family or five (5) persons were affected in **Brgy. Bitoon, San Ricardo, Southern Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bitoon, San Ricardo, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,106.38** worth of assistance was provided to the affected family; of which, **₱9,106.38** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
