

DSWD DROMIC Report on the Fire Incident in Brgy. Bocana, Ilog, Negros Occidental

19 February 2025, 6AM

I. Situation Overview

On 12 February 2025 at around 7:30 AM, a fire incident occurred in Brgy. Bocana, llog, Negros Occidental.

II. Status of Affected Areas and Population

A total of six (6) families or 36 persons were affected in Brgy. Bocana, llog, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **36 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of six (6) houses were damaged; of which, four (4) are totally damaged and two (2) are partially damaged in Brgy. Bocana, llog, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱100,116.00 worth of assistance was provided to the affected families; of which, ₱40,116.00 from DSWD and ₱60,000.00 from the Local Government Unit (LGU) (see Annex D).
