I. Situation Overview

On 28 January 2025 at around 2:43 PM, a fire incident occurred at Fort San Pedro, Brgy. Veterans Village, Iloilo City. The fire was declared out at around 3:45 PM.

II. Status of Affected Areas and Population

A total of three (3) families or nine (9) persons were affected in Brgy. Dugong, Bucay, Abra (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Dugong, Bucay, Abra (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱43,764.20 worth of assistance was provided to the affected families; of which, ₱40,264.20 from DSWD and ₱3,500.00 from the Local Government Unit (LGU) (See Annex D).
