I. Situation Overview

On 06 February 2025 at around 6:30 AM, a fire incident occurred in Brgy. Igiunrindon, San Remigio, Antique.

One (1) family or three (3) persons were affected in **Brgy. Igiunrindon, San Remigio, Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Igiunrindon, San Remigio, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,425.44** worth of assistance was provided to the affected family; of which, **₱4,175.44** from **DSWD** and **₱1,250.00** from the **Local Government Unit (LGU)** (see Annex D).
