I. Situation Overview

On 12 February 2025 at around 1:00 PM, a fire incident occurred in Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental.

V. Cost of Humanitarian Assistance Provided

A total of **₱8,078.00** worth of assistance was provided to the affected family; of which, **₱7,438.00** from **DSWD** and **₱640.00** from the **Local Government Unit (LGU)** (see Annex D).
