I. Situation Overview

On 10 January 2025 at around 2:33 PM, a fire incident occurred at a residential house in Zone 3, Brgy. Luac, Bani, Pangasinan.

One (1) family or two (2) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Luac, Bani, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱24,459.35** worth of assistance was provided to the affected family; of which, **₱20,959.35** from **DSWD** and **₱3,500.00** from the **Local Government Unit (LGU)** (see Annex D).
