

DSWD DROMIC Report on the Fire Incident in Brgy. Madarag, San Enrique, Iloilo

20 February 2025, 6PM

I. Situation Overview

On 16 February 2025 at around 11:30 AM, a fire incident occurred in Brgy. Madarag, San Enrique, Iloilo. The fire was declared out at around 12:00 PM.

Outside Evacuation Center
One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Madarag, San Enrique, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱16,210.00 worth of assistance was provided to the affected family; of which, ₱6,210.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
