

DSWD DROMIC Report on the Fire Incident in Brgy. Madarag, San Enrique, Iloilo

I. Situation Overview

On 16 February 2025 at around 11:30 AM, a fire incident occurred in Brgy. Madarag, San Enrique, Iloilo. The fire was declared out at around 12:00 PM.

One (1) family or **five (5) persons** were affected in **Brgy. Madarag, San Enrique, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Madarag, San Enrique, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,210.00** worth of assistance was provided to the affected family; of which, **₱6,210.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
